- Legislative: Cleveland provided an update on the following: Government Ops committee is hearing more this week re: the COVID presumption bill (MAFC position is currently supportive). HB4648 (advisory committee for certain building codes MAFC neutral position. SB363 (concurrent to previous HB, MAFC is taking same neutral position). HB4171 (extending cancer presumption to ARFF & Forest FF) & HB4172 (PT/Paid On-call, & Vol as well as addd certain female related cancers. MAFC position is of support). HB4077 (unmanned gas stations). HB 4382 (smoke alarm devices requiring sealed lithium ion batts. Many discussions.) This is probably not getting to the Boards prior to summer recess. HB4070 & 4247 (expanding family funding for LODDs). Medicaid reimbursement for transporting agencies (asking for this to be raised. MAFC continues to work on this.) Expanding crime or assault of a public service employee (looking to expand to ER personnel / MAFC supports). Eliminate helmet requirements (MAFC is not supporting).
